- Preparation of a European data model started:
 - Initial workshops on the topic, basic discussion in a smaller circle, goals (NL, B, S, DK, D).
 - Proposal for bottom-up approach taken up by EIOPA

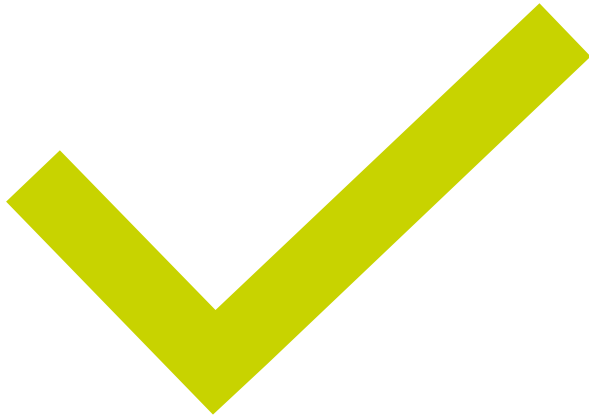


ETS Organization

- ETS association: public/private, scenarios to be presented and concluded in 2022
- Solution for privacy law compliance, relations of data sources to ETS
- Engagement of and exchange among NTSs
- Forum on Pension Communication also includes pension providers and other stakeholders



EIOPA – EC request for TA on PT – public consultation.



- Technical features proposed by ETS project are underlined by EIOPA draft paper on advice
- Call for NTSs to introduce eIDAS compliant authentication method for connection with ETS
- Governance and business model related: EIOPA takes view that both ETS and PTS are public goods – consequences for funding
- Supporting common development of standard for transfer and presentation of data to ETS (European data model)
- PTS/ETS should be non-profit, independent, credible and transparent. A public private partnership provides optimal form. Introduction of a European Forum of NTS and experts on pension communication.
- Support of PensionsEurope in the public consultation
